## LED COLOR CHANGING SHIFT KNOB

### CONTENTS:

- 1 - LED Color Changing Shift Knob
- 1 - Allen wrench
- 4 - Spacers (3/8", 7/16", 1/2", 9/16")

### INSTALLATION:

- 1) Remove existing shift knob from vehicle.  
*NOTE: For use on manual transmission only.*
- 2) Remove mounting base from ANCCGK (see diagram).
- 3) Mount shift knob using adapters and hardware provided.  
*NOTE: Be sure to install mounting base on shifter post first.*
- 4) Tighten screws on shift knob and re-install mounting base.
- 5) Enjoy!

### OPERATION:

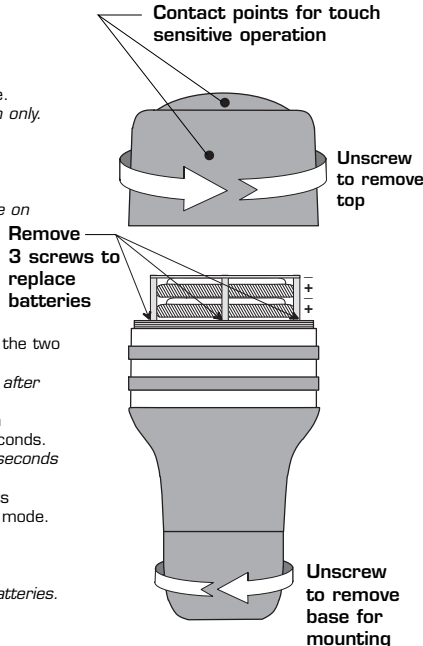
- 1) To activate color-changing cycle, touch the two contact points shown (see diagram).  
*NOTE: Cycle will last for 120 seconds, after which the unit will turn off.*
- 2) To active a constant cycle mode, touch the contact points 3 times within 2 seconds.  
*NOTE: Unit will not turn off after 120 seconds in constant cycle mode.*
- 3) To turn unit off touch the contact points 3 additional times after constant cycle mode.

### BATTERY REPLACEMENT:

See diagram for battery replacement.  
*NOTE: Use only CR2450 3v Lithium Cell batteries.*
