## 15' EL WIRE

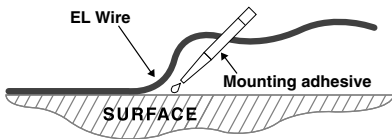
### IMPORTANT!

Before you begin installation decide the length and location carefully. The wire adhesive is permanent and cannot be removed without damaging the EL Wire. Install from the beginning so that you can trim the cable if necessary at end. Do not install in locations where the EL Wire will flex continuously. This will eventually damage the EL Wire.

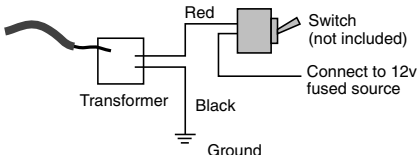
### WARNING!

The adhesive provided will bond to almost any surface and can damage surface upon removal of wire. EL Wire adhesive is an eye irritant and will bond skin in seconds. Be extremely careful when applying the adhesive and avoid contact with skin.
